Arts of Tolland, Inc. will retain a 20% commission on all works sold. All taxes are the responsibility of the artist. Artwork is to remain on display for the duration of the show.

# LIMIT

Two entries per artist. Each piece not to exceed 40", including the frame.

#### **ELIGIBILITY**

Open to all artists 18 years old and older.

Artwork to be hand-delivered to the Arts Center of Tolland, 22 Tolland Green, Tolland CT.

Original artwork only; no reproductions, no crafts, no photography, no free-standing sculpture.

Works should be wired and ready to hang. No tooth-hooks will be allowed.

Works previously exhibited in any Arts of Tolland Juried Show are not eligible.

## **PICK-UP**

All <u>non</u>-accepted entries MUST be picked up on Saturday March 22, 9 – 11 a.m. Accepted entries are to be picked up on Sunday, April 27, from 4 to 6 p.m. <u>No early pick-ups</u>.

Paintings not picked up are subject to a \$5 per day storage fee.

### **NOTIFICATION**

Artists will be notified by email or telephone of acceptance, non-acceptance, and awards.

**JUDGE:** Janet Leombruni is currently President of CT Women Artists and is an elected member of CT Academy of Fine Art and West Hartford Art League. She has exhibited throughout Connecticut as well as in New York, Rhode Island, and California. She received her BA from Hartford Art School, MA in Education from UConn, and MastersPlus 30 from CCSU. An acrylic painter from Wethersfield she paints the stories of experiences inside and outside the classroom. They also portray stories shared by her students, examining themes of hope, impulsivity, family, fantasy, innocence, and coming of age.
